WELCOME IN OSTROŁĘKA!

This brochure is for you - migrants who are newly residents of our town. We've gathered here all the useful information about institutions and Town Halls.

We would like you to know what your rights and obligations in Poland are, and where vou can look for information or help in particular situations. This booklet is a guide to how our town is organised and where can you settle various mat-

According to Polish legislation concerning foreigners, the rights of migrants vary depending on their legal status and the type of document that entitles a particular person to stav in Poland. Therefore, not every migrant has the same right regarding health care or employment. Not everyone has access to the services provided by the Employment Office (Urząd Pracy) – but many people do!

It is good to know that there various opportunities available to everyone regardless of their legal status, such as the possibility of medical assistance in life-threatening situations, or access to a library or museum. Also, it is worth knowing that there are non-governmental organisations in Poland that offer a variety of assistance for free.

> The key thing is: each of you has the right to be treated equally, to be safe, to have equality in the workplace, to be respected.

We wish you to benefit from these rights in Poland as much as possible.

Matters concerning legalisation of stay in Poland (changes of residence card, applying for a new card) shall be dealt with in the Voivodeship Office (Urząd Wojewódzki) in Warsaw. There is a branch of the Voivodeship Office in Ostrołęka - you can submit your application for legalisation here, but without the possibility of verification of the submitted documents by an official. The case is then forwarded to Warsaw for processing.

For a personal submission of the application, which allows verification of the documents and obtaining a stamp in the passport legalising further stay when the documents are complete, an appointment must be made through the online form. You can also submit your application to the registrar's office or send it by post. The form and other information about legalisation are available on the website:

LEGAL AID

There are free legal aid points in Ostrołęka for those who cannot cover the costs

of paid legal aid assistance. The assistance does not concern the legalisation of stay. It may concern labour, civil, criminal, family and other areas of law. The aid concerning conducting business and matters related to this is not provided. The counselling is available in Polish.

SOCIAL ASSISTANCE

The possibility to benefit from social assistance in Poland depends on the foreigner's legal status. As a general rule, support from assistance institutions may be provided to persons who have the permanent residence right in Poland (permanent residence card, EU long-term residence, refugee status or subsidiary protection).

Persons with a temporary residence permit in Poland are entitled to receive aid in the form of shelter or food in certain cases. You can find out about the available types of assistance at the Municipal Family Support Centre (Miejski Ośrodek Pomocy Rodzinie).





INSURANCE

Everyone who works legally (on an employment contract or commission agreement) in Poland is covered by mandatory social security and health insurance the employer pays contributions to Social Insurance Institution (ZUS) on behalf of the employee.

If a foreigner is unemployed, they can buy voluntary health insurance in National Health Fund (NFZ), which entitles them to use the public health service (in November 2020, its monthly cost is approximately PLN 470).

HEALTH CARE

The public health care system in Poland operates on the basis of health insurance - patients can receive free treatment in state hospitals and clinics only if they are insured. Only life-saving help is free for everyone.

PRIMARY HEALTH CARE (PODSTAWOWA OPIEKA ZDROWOTNA, POZ)

IN OSTROŁĘKA:

POZs are health centres where you can find a family doctor, paediatrician, general practitioner or dentist. There are many Primary Health Care centres in Ostrołęka which function as public or private but contracted by the National Health Fund entities. Both forms of POZ are available to those who pay (either themselves or through their employer) a health contribution - they are insured.

SUPPORT FOR PERSONS WITH DISABILITIES

In Poland, there is a support system for persons with disabilities. However, only people who have a disability certificate obtained in Poland can benefit from it. The disability certificate can only be obtained by foreigners who have a long-term right of residence in Poland.
